Modified Forms: Builder Application, Builder Affidavit, Builder Qualifications, Architect Affidavit, Landscape Architect Affidavit

Effective Date: March 2, 2020

These forms were approved by the Sovereign Oaks HOA Board on March 2, 2020, to replace pages 32-34 of the Sovereign Oaks Design Review Guidelines 5/17/2017 Revision. These forms must be signed and notarized by the Builder, Home Architect and Landscape Architect prior to scheduling a Final Design Review. The Design Review Committee is empowered to postpone a Final Design Review pending receipt of the completed forms.

I acknowledge and agree that:

- I have read and understand the Sovereign Oaks Covenants, Conditions and Restrictions (CCR's), the Sovereign Oaks Design Guidelines and the Sovereign Oaks Construction Guidelines and will follow and obey the policies and procedures as described.
- 2) When building in Sovereign Oaks, I am responsible for compliance with all municipal, state and federal laws which may be applicable.
- 3) I understand that should a violation of municipal, state or federal regulation or law occur the Sovereign Oaks Design Review Committee has the right to terminate the Contractor's right to be an approved builder.
- 4) I have read and understand the Statement concerning legal action, below.

Builders and/or Contractors who bring a legal action (in compliance with Article XI, Section 8 of the Declaration of Covenants, Conditions and Restrictions for Sovereign Oaks or otherwise) against the Sovereign Oaks Homeowners' Association, Inc. will have their "approval status" temporarily revoked for any and all future projects in the Sovereign Oaks community pending the final outcome of the dispute. For purposes of this provision, "Future Projects" shall be defined as any project where the contractor and the homeowner have not yet entered into a contract for services.

Should the dispute result in favor of the Builder or Contractor, their approval status will be reinstated. Should the action result in favor of the Sovereign Oaks Homeowners' Association, Inc., the Builder's/Contractor's approval status will be permanently revoked. In the event the dispute is resolved through a negotiated settlement, the parties shall negotiate the contractor's rights in the community on a case by case basis.

Changes to approval status under this provision shall not impact any ongoing projects at the time the legal action commences (meaning projects where there is a signed contract between the contractor and the homeowner), thereby not preventing a Builder/Contractor from finishing an active project.
